

SUMMARY ANNUAL REPORT FOR
AUTOMOTIVE INDUSTRIES PENSION PLAN

This is a summary of the annual report of the Automotive Industries Pension Plan, EIN 51-0136480, for December 31, 2001. The annual report has been filed with the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statements

Benefits under the Plan are provided by the Trust. Plan expenses were \$69,069,729. These expenses included \$4,389,557 in administrative expenses and \$64,680,172 in benefits paid to or for participants and beneficiaries. A total of 28,287 persons were participants in or beneficiaries of the Plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of the Plan assets, after subtracting liabilities of the Plan, was \$1,315,462,565 as of December 31, 2001 compared to \$1,364,647,601 as of December 31, 2000. During the plan year, the Plan experienced a decrease in its net assets of \$50,319,358. This decrease includes unrealized appreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$18,750,371, including employer contributions of \$25,141,519, gains of \$8,576,918 from sale of assets, interest of \$43,436,693, dividends of \$9,353,882, a loss in value of investments of \$68,322,705, other income of \$70,996 and net investment gain of \$493,068. In addition, a transfer from another plan of \$1,134,322 was made.

Minimum Funding Standards

An actuary's statements shows that enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

1. An accountant's report;
2. Financial information and information on payments to service providers;
3. Assets held for investment;
4. Transactions in excess of five percent of plan assets;
5. Actuarial information regarding the funding of the plan; and
6. Information regarding any common collective trust in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and the accompanying notes will be included as part of that report. The charge to cover copying costs does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

Department of Labor in Washington, D.C., or to obtain a copy from the U. S. Department of Labor upon payment of copying costs.
