**Bright Now! (Newport) Dental Plan Option is Terminating
Effective September 1, 2019**

Effective for dental services received on or after September 1, 2019, the Fund is terminating the Bright Now! (Newport) dental plan option.

If you are currently enrolled in the Bright Now! (Newport) dental plan option, you may choose to instead enroll in one of the Fund's remaining dental plan options: Delta Dental PPO, Safeguard, United Concordia Plus, or UnitedHealthcare Dental/Pacific Union Dental. **To elect a dental plan option, you must complete and return the enrollment change form and select your new dental plan option by August 31, 2019.** Enrollment change forms are available from the Trust Fund Office, or online at <https://aitrustfunds.org>.

If you fail to make an election or otherwise fail to return a completed enrollment change form to the Trust Fund Office by August 31, 2019, you will be automatically enrolled in the Delta Dental PPO plan option.

If you enroll in a Pre-paid Dental Plan (Safeguard, United Concordia Plus, or UnitedHealthcare Dental/Pacific Union Dental), you will receive your EOC for your Pre-paid Dental Plan and an ID card for each family member. With your enrollment choice, your cards will be automatically ordered for you from your carrier. If you are currently in the middle of a course of treatment, please contact your new dental plan option for any available transition benefits:
