## SUMMARY ANNUAL REPORT FOR AUTOMOTIVE INDUSTRIES WELFARE PLAN

This is a summary of the annual report of the Automotive Industries Welfare Plan, EIN 94-6078226, for the year ended December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Automotive Industries Welfare Plan has committed itself to pay certain medical, dental, orthodontia, disability, basic life, accidental death and dismemberment, vision and prescription drug claims incurred under the terms of the Plan.

### Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., Managed Health Network and Vision Service Plan to pay certain medical, prescription drug, and vision claims incurred under the terms of the Plan. Certain life insurance and stop-loss benefits are provided through contracts with ReliaStar Life Insurance Company and Berkshire Hathaway Specialty Insurance Company. Certain dental benefits are provided through contracts with Safeguard Health Plans, Inc., a California Corporation, United Concordia Dental Plans of California, Inc., United Healthcare Insurance Company, and Delta Dental of California. Premiums paid for the plan year ended December 31, 2021 totaled \$31,228,095.

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the Plan, was \$49,729,531 as of December 31, 2021, compared to \$46,944,313 as of January 1, 2021. During the plan year the Plan experienced an increase in its net assets of \$2,785,218. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$55,076,972, including employer contributions of \$51,233,442, employee contributions of \$214,336, realized gains of \$251,038 from the sale of assets, earnings from investments of \$1,688,359 and other income of \$1,689,797.

Plan expenses were \$52,291,754. These expenses included \$2,526,514 in administrative expenses and \$49,765,240 in benefits paid to participants and beneficiaries.

3. Assets held for investment;
4. Transactions in excess of 5% of plan assets; and
5. Insurance information, including sales commissions paid by insurance carriers.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 4160 Dublin Blvd., Suite 400, Dublin, CA 94568, and at the U.S. Department of Labor in Washington, DC or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
