SUMMARY ANNUAL REPORT FOR AUTOMOTIVE INDUSTRIES WELFARE PLAN

This is a summary of the annual report of the Automotive Industries Welfare Plan, EIN 94-6078226, Plan No. 501, for the year ended December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Automotive Industries Welfare Plan has committed itself to pay certain medical, dental, orthodontia, disability, life, vision and prescription drug claims incurred under the terms of the Plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan, Inc., United Healthcare of California, HMC Healthworks, Inc., and Vision Service Plan to pay certain medical, prescription drug, and vision claims incurred under the terms of the Plan. Certain life insurance and stop-loss benefits are provided through contracts with ReliaStar Life Insurance Company and Berkshire Hathaway Specialty Insurance Company. Certain dental benefits are provided through contracts with Safeguard Health Plans, Inc. A California Corporation, United Concordia Dental Plans of California, Inc., United Healthcare Insurance Company, and Delta Dental of California. Premiums paid for the plan year ended December 31, 2023 totaled \$30,536,554.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$47,282,859 as of December 31, 2023, compared to \$45,088,996 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$2,193,863. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$60,381,757, including employer contributions of \$48,696,648, participant contributions of \$159,822, realized losses of \$189,011 from the sale of assets, earnings from investments of \$4,332,561, and other income of \$7,381,737.

Plan expenses were \$58,187,894. These expenses included \$2,753,643 in administrative expenses, and \$55,434,251 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
